





By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. (the "Federation") and the local rules of Great Southwest Equestrian Center (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the Stateof New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

If not currently a USEF Active Competing member or Subscriber, I acknowledge that I will be enrolled for no cost as a USEF Fan and my USEF Fan Account will continue to annually automatically renew in USEF's sole discretion. 

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

# **ENTRIES**

Enter online at www.horseshowsonline.com. Every entry blank must have the signature of the owner/authorized agent, trainer & be accompanied by an open check or valid credit card information. NO NUMBERS WILL BE ISSUED WITHOUT AN OPEN CHECK OR VALID CREDIT CARD INFORMATION. There will be a \$75.00 office & services fee for every horse on the show grounds. Management reserves the right to refuse any entry for any reason.

Horses, on the grounds, not entered in any classes, must have a completed entry blank on file in the office and will be charged a \$100 non showing fee per week. Horses not accruing a minimum of \$100 in entry fees may be charged the non-showing fee in lieu of entry fees.

\*Warning: Horses that compete in a class in which they are not properly entered will be charged a double entry fee.

\*Attention foreign exhibitors: All fees MUST be paid in "US Funds".

In order to ensure correct number of horse and tack stalls, number of shavings and any feed or hay orders, please fill out the STALL RESERVATION FORM on GSWEC.com

# ENTRY CLOSING DATE

Entries are due by Jan. 15th. Post entries/New entries (new or different horses) made after this date will incur a one-time late fee of \$75.00.

# ADDS/SCRATCHES

All ADDS must be completed online at www.horseshowonline.com the Show Office NO LATER THAN 4:00pm the day PRIOR to the class. Time permitting, same day adds will be accepted at the ingate and will be put on a wait list of each show ring. Scratches will be accepted at any time prior to the start of the class – Scratch Fee may apply. Any scratches in the Derby after 5:00pm the night prior to the Class will incur a \$35 Scratch Fee.

# **COMPETITION NUMBERS**

**OFFICE ISSUED NUMBERS** must be worn in the competition rings.

# **SHOW OFFICE**

# TRAINER'S SPLITS

The horse show offers a service that allows the trainer to purchase shavings, feed, tack stalls, etc. directly from the Horse Show and then split the total amount for some or all of these items. Trainer splits will be accepted until noon Friday (no exceptions) of each show week. Trainers are reminded that this is a service provided by the Horse Show and that doing splits in a timely manner is their responsibility. Additionally, any splits uncollected from the client will revert back to the trainer for payment.

# SETTLEMENT OF ACCOUNTS

All show accounts must be closed out at the end of the week. Any open entry accounts will be closed by management and a \$60 processing fee will be added per entry. All questions about show accounts must be addressed within 48 hours of the conclusion of the show. Any mistakes or questions regarding your horse show account and/or prize money must be resolved within 48 hours by contacting the Horse Show Office. FOR CREDIT CARD PAYMENTS PLEASE NOTE: You MUST have your credit card present at check out.

# **REFUNDS**

STALL FEES CANNOT BE REFUNDED AFTER Jan. 15. Entry fees will not be refunded after **Jan. 15**, unless a certificate of illness or injury prepared by an accredited veterinarian, or a doctor's note regarding rider illness/injury, is presented to the secretary before the start of the show. Once the show has started, proper notification of the scratch must be made in the office **BEFOR**E the start of the classes being scratched. In either case the entry fee will be refunded less any nominating fees, stall fee, and an office processing charge of \$75.00. Any unprocessed prize money or refund checks outstanding six months after issuance date will be forfeited.

# NON-NEGOTIABLE CHECKS

A \$50.00 SERVICE FEE OR 10% OF THE CHECK AMOUNT/ CREDIT CARD CHARGE, PLUS EXPENSES INCURRED TO COL-LECT FEES, WHICHEVER IS GREATER, WILL BE CHARGED FOR ALL RETURNED CHECKS AND/OR DECLINED CREDIT CARDS.

# **CREDIT CARD FEE**

A convenience fee of three percent (3%) of the total invoice will be added to all invoices being paid with a credit card.

# **USEF/USHJA FEES**

Current USEF rules relating to drugs and medications will be enforced. Each horse entered must pay the \$15.00 USEF Drug/Medication Fee plus an \$8.00 USEF fee. Each horse entered will also be required to pay the USHJA Fee of \$10.00. (Total USEF/USHJA Fees \$33.00).

# **NOMINATING FEE**

Horses competing in all 1.20 Meter classes, and above, must pay a nominating fee of \$180, unless otherwise stated.

# RINGSIDE VIDEO AMENITIES FEE

This \$50 fee includes the cost of video & display monitors for ringside instant replay as well as live streaming when available. Videos can be viewed at.JKvideo.co All rings are equipped with an outdoor monitor to view an instant replay of your completed round. All rounds can be watched the week of the show. Video downloads are subjected to additional fees. The \$50 fee is limited to two charges per owner/lessee per show.


# NIGHT WATCH FEE

All horses occupying a stall, showing and non-showing, will be required to pay a show night watch fee of \$25. Horses will be checked each night of the show week every 2 hours. This service is **NOT** optional. USEF rule: HJ107i. Night Watch: Security and monitoring service offered to exhibitors, which must be available to contract at an additional cost, for horses stabled on the grounds.

# RV SPOTS

RV spots are limited and come on a first-come-first-serve bases. Please fill out a request prior to Jan. 15th. Premium RV spots cost \$375/week and Original RV spots cost \$325/week. The fees include a pump out on Saturday. Additional pump outs available at an additional fee.

# Prize Money to Foreign Exhibitors:

Foreign exhibitors are advised that the US Internal Revenue Service requires sporting events to withhold 30% of the prize money won in the United States. Foreign exhibitors should apply for a US Social Security number and will be asked to complete FORM W8-BEN prior to prize money being issued. A valid Social Security or Federal ID number must be provided. Prize money will be withheld if the recipients Social Security number is not on file.

# RIBBONS/TROPHIES/CHAMPIONSHIPS

All hunter classes receive a trophy and eight ribbons unless otherwise noted. All equitation classes receive a prize and eight ribbons unless otherwise noted. All jumper classes receive a prize and eight ribbons unless otherwise noted. Each hunter and jumper section will receive a champion & reserve award based on points unless otherwise noted. Full Championship points will be given in all classes in each hunter section except Green Conformation Hunter Model which will count as half points. In all hunter sections, Champion and Reserve Champion will be awarded to two of the top four horses acquiring the most points over fences. These four horses will also receive full points for one under saddle class. All ribbons and prizes can be picked up at the designated Ribbon and Prize room located in the offices next to the Main Arena.

# HORSE REGISTRATION

All horses competing in Federation non-breed restricted licensed competitions with hunter, hunter breeding, jumper and hunter seat equitation classes (except those activities enumerated in GR901.9. items 1-9) must be properly identified and must obtain a Registration Number from USHJA. A registration number for each horse must be entered on all entry forms for licensed competitions. Proof of registration must be presented to the Show Secretary before numbers can be released. To be eligible for National, Regional or Zone Horse of the Year Awards, and to enter a USEF Computer Ranking List Class horses must also be registered with the USEF. Exception for USEF Computer Ranking List: Citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation need not have USEF Registration.

# **CREDENTIALS**

All exhibitors in any pony, pony equitation, Junior Hunter or Amateur section MUST present their credentials (MEASUREMENT CARD OR AMATEUR CERTIFICATION) to the show office before their numbers can be released. Please submit a photocopy of credentials with entry to facilitate processing. All horses or ponies without a valid measurement card will be measured at a designated time and place. Anyone not presenting valid membership credentials (USEF/USHJA) will have to fill out a USEF/USHJA Show Pass form and will be charged a \$30.00 nonrefundable show pass fee for USHJA and \$45.00 non-refundable show pass fee for USEF. Amateur exhibitors must present valid Amateur Credentials. Only a parent will be exempt from the Federation non-member fee if signing as coach for his/her minor child.

# US EQUESTRIAN FEDERATION MEMBERSHIP **AGREEMENT**

Eventing Competitions at the Modified Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes: 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes

# THJA MEMBERSHIP STATEMENT

THJA Members shall be eligible to participate in all classes at competitions recognized by THJA. A person/horse may register with the THJA at a recognized horse show as long as the application(s) and payment accompanies the official horse show results. Registrations may also be completed online with a credit card at the THJA website before the end of the show. All riders and trainers, in addition to owners of THJA registered horses must be members of THJA for the points to count.

# THJA RECOGNITION

The Great Southwest Fall Classic is operated in accordance with the current rules of the Texas Hunter and Jumper Association by which they are recognized and rated "A" in Performance Hunters 3'3" and 3'6", Green Hunter 3', Green Hunter 3'3", Green Hunter 3'6", Green Hunter 3'9", Amateur Owner Hunters 3'3" and 3'6", Pony, Green Pony, Junior Hunters 3'3" and 3'6", Children's Pony Hunter, Children's Hunter, Adult Hunter, Low Adult and Low Children's Hunter, Short, Medium and Long Stirrup Hunter and JR/AO, Children's and Adult Jumper. Points for placing in Junior, Children's, Pony and Adult Equitation and Hunter Breeding Horses and Opportunity Walk/Trot Hunters and Opportunity Cross Rails Hunters will be credited in accordance with the rules of THJA.

# ANIMAL WELFARE

We require that all horses be treated with kindness, respect and compassion and should never be subject to mistreatment. Owners, trainers, riders and grooms, or their agents must use reasonable care in the handling and treatment of their horses whether owned or placed in their care for competition or for any other purpose. At all times, while the horse is on the show grounds, we will provide for the continuous well-being of the horse. Abuse and use of whips will be strictly enforced. No poling, use of bamboo off set or excessive use of the whip will be tolerated. The well-being of the horse must be considered above the demands of the breeders, trainers, riders, owners, dealers, organizers, sponsors or officials. Violators may be subject to penalties pursuant to USEF rules. In the event of an acute and serious injury to or illness of a horse on competition grounds when the owner or trainer of the horse or agent of the owner is not present, after reasonable effort to contact that individual has been made, competition management, in consultation with a licensed equine veterinarian, may authorize the provision of emergency veterinary treatment of the horse. If competition management so authorizes treatment under the provisions of this rule, competition management and veterinarian are not liable for any resulting costs, damages, losses, claims or actions arising directly or indirectly from the treatment of the horse.

# **HEALTH REQUIREMENTS**

GR845 EQUINE VACCINATION RULE: Horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the show grounds. Horses without proper proof of vaccines will not be permitted to enter the show grounds.

# **HEALTH CERTIFICATES/COGGINS TEST**

A Health Certificate dated within 21 days of arrival to be presented when entering the show grounds. CVI must state the horse(s) has not been treated for an elevated temperature or anything related to herd health in the last 21 days. Horses without a Health certificate will not be permitted to enter the show grounds. Texas law requires that each horse be accompanied by a negative EIA certificate dated within one year. Horses without a negative EIA certificate will not be permitted to enter the show grounds.

# **HEALTH PAPERS**

Please have a printed copy of your horse health papers to be left at the check-in location prior to entering The Great Southwest Equestrian Center.

# FEDERATION ENTRY AGREEMENT

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the competitions listed herein. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. 
